Motion by Hendrickson 2<sup>nd</sup> VanDyke to approve the Grant Request from Mt. Hope/Funks Grove Park District for \$2500.00. ROLL CALL- VanDyke, Hendrickson, Shifflet and Hawkins. All ayes, motion carried. Absent: West and Billington.

UPDATE VILLAGE CODE: Motion by Shifflet  $2^{nd}$  Hendrickson to adopt and ordinance but not to make changes to the code based on changes to Illinois Law that only affect the Village for \$900.00. ROLL CALL-Hendrickson, Shifflet, Hawkins and VanDyke . All ayes, motion carried. Absent: West and Billington.

Discussion on having Mavidea on a month to month basis. It is very expensive and Katie Funk does a lot of this. Will rethink the agreement with them. Will table this until August meeting and Karen will speak to Katie.

Discussion on transferring funds from the Atlanta National Bank to other institutions. Motion by VanDyke 2<sup>nd</sup> Hendrickson to have Karen move monies from Atlanta National Bank to CDARS with 1<sup>st</sup> State Bank. ROLL CALL-Shifflet, Hawkins, VanDyke and Hendrickson. All ayes, motion carried. Absent: West and Billington.

Discussion on customer payment options for Utility Bills. Proposal from CUSI. Will table this for now.

Roof on the Village Office should start around first week of July.
