

VILLAGE OF MCLEAN REGULAR BOARD MEETING MARCH 6, 2017

President West called the regular meeting of the board to order at 7:00pm. ROLL CALL-Hodge, Lane, Shifflet and Hammel. Absent: Leach. Also present: Attorney Mark McGrath, Greg Rutherford and Rick Davis. Visitors present: Helen Doty, Don Doty, LaVerne Isringhausen, Troy Bryant, Jane Price, Amy West, Leigh Demling(and sons) and Virgil Isringhausen.

Motion by Hammel 2nd Hodge to approve minutes of Feb. 6, 2017 board meeting. All ayes, motion carried. Absent: Leach,

Motion by Hammel 2nd Hodge to accept bills as presented. ROLL CALL-Lane, Shifflet, Hammel and Hodge. All ayes, motion carried. Absent: Leach.

PUBLIC INPUT: Amy West from CORE asked if Morgan St. by the new mural could be closed on April 8, 2017 from 1:00-3:00pm for the dedication of the mural. Since it was not on the agenda this will be tabled until the April 3, 2017 board meeting.

Rutherford reported the arsenic report will be sent in tomorrow(3-7-17).

West stated has not heard anything from the Road Ranger.

WATER TOWER: Got the cathodic protection(protect paint on tower). Also, will put on a filter. West questioned why Caldwell is not fixing this. Rutherford will call Caldwell. It was stated that the read outs are not working right.

No roof bids.

Easement of Roberts Property-FS has it in their possesion.

Nothing on the use of the Park District for bad weather.

There was an administrative search warrant on 113 W. Charles St. It was stated it may have asbestos in it and a lot of water damage and in desperate need of repair. McGrath stated the procedure would be to file a law suit, ask court to have it fixed or demolished and serve to owner. If owner does not respond then we would win the case. The village would be responsible for demolishing it but could put a lien on the property. Davis asked if the person that demolished the Wilson propery could be contacted. McGrath stated yes. If property is deeded to the Village the person that bought the back taxes would need to be notified. It was stated that West, McGrath and Davis meet and work with the owner.
