### C. Update on TIF Redevelopment Projects by the Village of McLean

A 2016-2017 TIF Report was sent to all parties. Highlights:

- Illinois Valley Construction completed its building and the street that adjoins the building. The remaining portion of the road is expected to be completed by the spring of 2018
- Road Ranger commenced substantial redevelopment of the Dixie Truck Stop including a new Subway and parking lot improvements.
- The Village of McLean paid Olympia C.U.S.D. #16 \$16,781.00 per the intergovernmental agreement.
