ORDINANCE NO. 15-11-02A

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEANTO PROVIDE AMENDMENTS RELATING TO WATER RATES, SEWER RATES AND UTILITY CHARGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §171.02(A) of the Village Code of the Village of McLean is hereby repealed and in its' place a new section (A) is hereby inserted, which is as follows:

§171.02(A) *Service Connection Fee after Shut Off.* If following a shut off, a service reconnection can be completed during regular working hours of the public works department, then the customer shall pay in advance to the village all outstanding water and sewer charges and a reconnection fee of \$50.00. In the event that a service reconnection cannot be completed during regular working hours of the public works department, then the customer shall pay in advance to the village all outstanding water and sewer charges and a reconnection fee of \$95.00. However, no reconnection fee shall be paid by any military personnel who requests a service reconnection, after shut off, if the military personnel was deployed or mobilized for active duty at the time of shut off.

SECTION 2: §171.02(B)(1)(2)(3) of the Village Code of the Village of McLean is hereby repealed and in its place a new subsection is hereby inserted which is as follows:

§ 171.02(B) *Utility rates.* There shall be a minimum rate of 2,000 gallons for all users. The following rates shall apply to water that is delivered to a customer.

(1) Water rates.

Gallons per Month	Residential Rate per 1,000 Gallons	Commercial and Bulk* per 1,000 Gallons
2,000-6,000 gallons	\$7.70	\$9.90 **
6,001 and over	\$9.13	\$9.90
*Bulk water is defined as any water used that was not metered.		
** Minimum monthly residential rate charge is \$21		
***Minimum monthly commercial & bulk rate charge is \$27		

(2) Sewer rates.

Gallons of Water Used per Month	Residential Rate per 1,000 Gallons	Commercial and Bulk* per 1,000 Gallons
---------------------------------	------------------------------------	--

0-6,000 gallons	\$3.50	\$4.25
6,000 to Maximum	\$3.90	\$4.25
*Bulk water is defined as any water used that was not metered.		

(3) Annual rate increase. The water and sewer rates set forth in divisions (B) (1) and (2) and the minimum monthly rates specified therein shall be increased by 5% of the preceding's year's rate. All calculations shall be rounded up to the nearest \$.05 increment. The increase in water and sewer rates shall apply to water and sewer service that is required to be paid by the customer in January 2017 and each January thereafter.

SECTION 3: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 4: This Ordinance shall take effect on the 20th day of November, 2015.

SECTION 5: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
