AN ORDINANCE CORRECTING ORDINANCE 12-08-20 TO CORRECT AN ANNEXATION ORDINANCE TO DELETE A LEGAL DESCRIPTION FOR PROPERTY THAT WAS NOT ANNEXED TO THE VILLAGE OF MCLEAN

WHEREAS, the Village of McLean adopted Ordinance 12-08-20 on August 20, 2012;

WHEREAS, Attached to Ordinance 12-08-20 was an annexation plat that correctly described the property that was annexed to the Village of McLean;

WHEREAS, inadvertently, Tract IX was included in the legal descriptions for the properties that were annexed to the Village of McLean and this property was not annexed to the Village of McLean.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN, MCLEAN COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: The facts and statements contained in the preambles to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

SECTION 2: An accurate plat of the property annexed to the Village of McLean was set forth as Exhibit "A" to Ordinance 12-08-20. This plat was correct and there are no changes to this plat as a result of this Ordinance.

SECTION 3: Tract IX set forth on Exhibit "B" is hereby deleted as a legal description for the property that was annexed to the Village of McLean. This property was never annexed to the Village of McLean and is not annexed to the Village of McLean.

SECTION 4: The legal description for Tract IX that was not and is not annexed to the Village of McLean is set forth as Exhibit "B", attached hereto and incorporated herein by reference.
