ORDINANCE NO. 17-03-06

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO RENEWAL OF LIQUOR LICENSE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §111.26 of the Village of Code of the Village of McLean is hereby amended by adding after the existing provisions of that Section the following additional provisions:

To renew a liquor license the licensee shall complete an application for a renewal of license as set forth in §111.16, shall be subject to examination as set forth in §111.17 and shall be subject to a criminal history check and examination as set forth in §111.18.

SECTION 2: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 3: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 4: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
