ORDINANCE NO. 17-03-06 A

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE  
PAID TO VILLAGE OFFICIALS

WHEREAS, the President and Trustees of the Village of McLean are elected officials; and

WHEREAS, the corporate authorities of the Village of McLean believe it is in the best interest of the Village and its residents to compensate Village officials fairly for their services on behalf of the Village; and

WHEREAS, it is necessary to establish the salary to be paid to each of the Village officials by ordinance; and

WHEREAS, salaries must be fixed by ordinance not less than one hundred eighty (180) days prior to the commencement of new terms of office.

NOW THEREFORE BE IT ORDAINED by the President and Board of Trustees of the Village of McLean, McLean County, Illinois, as follows:


SECTION 1: The following officers of the Village of McLean shall receive the following salaries for his or her services in the amount set forth below:

1. The Village President shall receive for his or her services rendered to the Village of McLean One Hundred Twenty-five Dollars (\$125.00) per regular, special and committee meeting attended commencing in May 2021.
2. Each Village Trustee shall receive as compensation for his or her services the sum of Fifty Dollars (\$50.00) per regular, special and committee meeting attended. This rate of pay is to become effective for each Village Trustee who is elected or appointed to a term which begins after the results of the November 6, 2018 election are certified by the County Clerk.
3. The Village Clerk shall receive as compensation for his or her services the sum of One Hundred Dollars (\$100.00) per regular, special and committee meeting attended This rate of pay is to become effective for the Village Clerk who is elected or appointed to a term which begins after the results of the November 6, 2018 election are certified by the County Clerk.

SECTION 2: This ordinance shall be in full force and effect from and after its passage, approval, and publication in a manner provided by law.
