## ORDINANCE NO. 30-05-04 A

AN ORDINANCE AMENDING THE VILLAGE OF MCLEAN MUNICIPAL CODE SAID MUNICIPAL CODE BEING ORDINANCE NO. 96-5-6A OF THE VILLAGE OF MCLEAN TO PROVIDE AMENDMENTS RELATING TO PERMITTED USES IN ZONING DISTRICTS

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN:

SECTION 1: §178.086(I) of the Village Code of the Village of McLean is hereby amended by deleting the entire existing provisions and inserting in place thereof the following:

§178.086(I) DWELLING, SINGLE-FAMILY

SECTION 2: §178.045 of the Village Code of the Village of McLean is hereby amended by adding the following at the end of the existing provisions of that Section:

A mobile home may only be located or placed withing the Village if it is located or placed in a mobile home park.

SECTION 3: §178.017 of the Village Code of the Village of McLean is hereby amended by deleting the definition of **DWELLING**, **MOBILE HOME** and title of that definition.

SECTION 4: §178.017 of the Village Code of the Village of McLean is hereby amended by adding the following definition which shall be inserted in proper alphabetical order:

MOBILE HOME. A structure, transportable in one or more sections, which is built on a permanent chassis and designed to be used for residential living with or without a permanent foundation when connected to the required utilities and includes plumbing, heating, air conditioning and electrical systems contained therein. The fact that a mobile home is placed on a permanent foundation and connected to utilities does not convert the mobile home into a dwelling.

<u>SECTION 5</u>: If any section or part of this Ordinance is held invalid, it shall not affect the validity of the remainder of this Ordinance.

SECTION 6: This Ordinance shall take effect 10 days after publication thereof as provided by law.

SECTION 7: Ordinance No.96-5-6A of the Village of McLean, as amended by this Ordinance, shall remain in full force and effect and all previous amendments to Ordinance No. 96-5-6A shall remain in force and effect except as modified by this Ordinance.
