A RESOLUTION AUTHORIZING THE DESTRUCTION OF AUDIO RECORDING OF CLOSED MEETING SESSIONS

WHEREAS, the Open Meetings Act requires governmental bodies to audio their closed meetings; and

WHEREAS, this governmental body has complied with that requirement by an audio tape or video; and

WHEREAS, the Open Meetings Act permits governmental bodies to destroy the verbatim record of closed meetings without notification to or the approval of Records Commission or the State Archivist not less than 18 months after the completion of the meetings record, but only after;

- 1. It approves the destruction of a particular recording; and
- 2. Approves written minutes of the closed meeting; and

WHEREAS, for the verbatim record by tape of the meeting(s) set forth in Section 1 of this Resolution, at least eighteen (18) months have passed since the completion of those meetings, and this governmental body has approved written minutes for each of the meetings or portions of the meetings set forth in Section 1; and

WHEREAS, this governmental body may order the destruction of the verbatim record even if it continues to withhold the approved written minutes of the closed session until some later period of time;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF MCLEAN, as follows;

Section 1: Based upon the statements made within the preamble to this Resolution, the Board of Trustees of the Village of McLean hereby orders the destruction of the verbatim record being an audio tape of the following full meetings or portions of the meetings from:

Section 2: This Resolution shall be in full force and effect immediately upon its passage.
